### VOLUNTARY RECALL

TORONTO, ONTARIO, NOVEMBER 9, 1995: GrandeTel Technologies Ltd. (formerly MTC Electronic Technologies Co. Ltd.) and the Canadian Standards Association (CSA) today announced that GrandeTel is voluntarily recalling approximately 55,000 MTC brand 14 inch and 20 inch colour televisions sold to wholesalers, distributors and retailers in Canada during the past three years. The MTC 14 inch and 20 inch colour television units involved are identified as models MTV1428R, MTV1428RF, MTV1429RF and MTV2030RF, as marked on the manufacturer's label attached to the rear portion of the television cabinet.

Grande Tel Technologies informed CSA that extensive product-use tests and an analysis of five recent consumer complaints had shown that under certain circumstances a resistor on the main component board may overheat, resulting in a potential fire hazard. Of these five reported incidents, two resulted in damage to the rear panel of the cabinet. Grande Tel is not aware any injuries. Grande Tel technicians have determined that the faulty resistor in question should be upgraded immediately by an authorized television repair centre.

Grande Tel Technologies has made arrangements with authorized service centres located across Canada to handle the replacement of resistors for affected television sets. The service centres will not charge the customer for such replacement service.

This recall involves the above-noted model units bearing the following serial numbers, which appear on the serial number label attached to the rear panel of each unit:







# REPLACEMENT OF RESISTOR ON MODELS

# MTV1428R/RF, MTV1429RF (13" CTV) AND MTV2030RF (19" CTV)

THE FOLLOWING PROCEDURE TO MODIFY THE AFFECTED TELEVISIONS IS STRICTLY VOLUNTARILY. IF YOU DO NOT WISH TO PERFORM THE REQUIRED MODIFICATION AS OUTLINED, PLEASE ADVISE THE TV OWNER OF THE RECALL PROGRAM AND ASK THE TV OWNER TO CONTACT US.

# TV'S FORWARDED FOR REPAIR AND SUBJECT TO THE RECALL

We anticipate that some TV owners may not be aware of the TV recall program and that MTC brand TVs forwarded to you for repair would still have the old CF resistor in question (cream colour). We request that you inspect the resistor (R320) as part of your process and automatically perform the replacement if required. You will be reimbursed a fee of \$18 (+ GST if GST Registration number is provided) for each completed Consent Form.

#### **CONSENT FORM**

Included in this pack is the "Consent Form" which is self explanatory, for signature by TV owner / representative and your own representative. Please have the TV owner / representative complete the data and sign the consent form immediately when the TV is delivered to your premises. This consent form must be attached to your invoices together with the original resistor replaced by your technician.

#### **REWORK PROCEDURE**

- Resistor R320 is a 2.2KΩ 1/2W 5% Carbon Film (CF) Resistor. This is to be replaced by a Fusible Metal Oxide
  of the same value and rating. The carbon film resistor has a shiny light cream body colour (same as other CF
  resistor used on the chassis) whereas the Fusible Metal Oxide resistor is of a dull grey body colour. DO NOT
  REPLACE R320 IF IT IS ALREADY OF A DULL GREY BODY COLOUR.
  - The resistor is located underneath one edge of the heat sink for the Horizontal O/P Transistor (Q302). Simply remove the existing CF resistor and replace it with the Fusible Metal Oxide Resistor supplied by GrandeTel.
  - Do not discard the carbon film resistor. It has to be attached to the Consent Form.
- 2. Resolder the solder joints for L301 (13" Models) or L301 and L303 (19" Models).

To expedite this process, we are including several pieces of the Fusible Metal Oxide Resistor to you at this time. The resistors are invoiced at no cost to you. You can order more as you require them.

#### MARKINGS AFTER REPLACEMENT IS DONE

We request that you leave a marking on the TV back cabinet to indicate the replacement Fusible resistor has been installed. The marking shall be a date code in the format of 'MM-DD-YY' (e.g., 11-15-95) on the white coloured "Inspected OK" sticker on the back cabinet. Please use a ball point pen or other non-water soluble marker.

# **CLAIM PROCEDURE**

GrandeTel is paying a flat rate of \$18 (GST extra) for this procedure. If R320 is already of the fusible type (grey body colour), NO MODIFICATION IS NEEDED AND NO FEE WILL BE PAID.

The following must be attached with your claim:

- 1. A completed Consent Form
- 2. The original Carbon Film resistor (cream colour body) removed must be taped to the Consent Form.
